3.2	<b>CHALLENGE</b> : JA sought clarity over whether the changes made were major or minor, which JB explained that the emphasis was now on World Views and the development of children having their own views formed through the influences of education, families and communities. The school is still working with the Maths Hub and using PiXI will help focus the areas of work. CS reassured the committee that the SDP has been informed from this set of data. <b>CHALLENGE</b> : RJ asked if the entire curriculum is to be	CHALLENGE
	reviewed, which CS stated that the writing curriculum will be reviewed to ensure all the strategies are linked across the cohort. This will also ensure that all strategies have a tangible impact for pupils. CS raised	CHALLENGE
